Recap of our meeting with our Scout leaders a few Sundays ago. After some discussion we recommend that Cub Scout Pack 310 gain their own tax identification number so they can stop using ours. Dennis is in the process of identifying and consolidating duplicate identifiers on the Quick books accounting program. This should clear up any confusion between our charitable giving and separate donations to Walk and Knock from those sometimes confused with Neighbors Helping Neighbors (e.g. everybody can't have the "food bank" moniker.)

Jim Kolshinski to work with Spectra (previously known as Ovations) on whether or not we have to pay sales tax when we work the fair grounds for events other than fair. It makes a substantial difference to our bottom line. Issue arises because during events other than fair we are acting as a sub-contractor of Spectra. Spectra has agreed that IF no sales tax is due from us and we have overpaid' they, Spectra will refund any and all overages.
